FULL TIME STUDENT

All full-time undergraduate/graduate/professional students attending the Huntington Campus are assessed \$169.50 per semester. A valid Marshall University Student ID is required for entrance.

PART TIME STUDENT

All part-time students attending the Huntington Campus are assessed a fee according to the number of credit hours taken up to 11 credit hours for undergraduates and 8 for graduate/professional students. Part-time undergraduate students are charged \$14.25 per credit hour and graduate/professional students are charged \$19.00 per credit hour. To become a member, a part-time student must pay the difference between the \$169.50 and the fee assessed by the university. Part-time students who enroll in a minimum of three credit hours may also purchase a single entry pass for \$6 in lieu of purchasing a full-membership. A valid Marshall University Student ID is required for entrance.

OFF SEMESTER STUDENT

Off semester students not enrolled for the current semester may purchase a membership at the voluntary student rate with proof of enrollment for the previous or upcoming semester.

SPOUSE/SIGNIFICANT OTHER/DEPENDENT

Spouse/significant other/dependent may purchase a membership for \$169.50; must satisfy two of the following criteria: proof of joint financial responsibility, same last name, marriage license, or same residence along with verifying identification for the member. Dependents must be 18 or older to sponsor guests. You must be 16 years or older to purchase a membership. A birth certificate is required for verification. Children and/or dependents age 15 and under may register to access the facility at no charge; they are required to be directly supervised at all times by a parent or guardian and are not allowed to use the fitness and weight equipment on the second and third floor; access is limited during the academic year. Children are allowed unlimited access during the designated summer months.
